

## StarHub 25 Ways To Celebrate Lucky Draw (“Lucky Draw”)

1. This Lucky Draw will take place from **1 April to 15 July 2025**, both dates inclusive (“**Lucky Draw Period**”).
2. This Lucky Draw will be governed by these standard terms and conditions (“**Terms**”). By participating in this Lucky Draw, you (“**the Participant**”) confirm that you have read and understood these Terms and that you agree to be bound by and to comply with these Terms. Non-compliance with or breach of any of the Terms may disqualify you, and any prize won by you may be forfeited, withheld, withdrawn or reclaimed.

### Eligibility

3. To participate in this Lucky Draw, you must be (i) at least eighteen (18) years old; (ii) be a StarHub customer with completed and closed order(s); and (iii) not have any outstanding bills or be blacklisted with StarHub Ltd and/or its related corporations (collectively referred to as “**we**” or “**us**” or “**StarHub**”) during the Lucky Draw Period, at the time of the draw, and at the time of the claim or use of the Prize.

For the purpose of this clause, “completed and closed order(s)” refers to orders for StarHub services for which all installation works or delivery of equipment (such as broadband installation and delivery of mobile phones) are completed by the end of the Lucky Draw Period.

4. Employees of StarHub, each of their immediate families, as well as StarHub’s commercial customers and bulk subscription customers, are not eligible to participate in this Lucky Draw.

### Lucky Draw Mechanics

5. In addition to meeting the above eligibility requirements, you will have to do the following to qualify as an eligible participant in the Lucky Draw (“**Eligible Participant**”):
  - a. Be an existing StarHub customer (to get 1 chance);
  - b. Recontract your existing StarHub plan (to get 1 additional chance); or
  - c. Sign up for a new StarHub mobile, broadband and/or entertainment plan (to get 2 chances).

A maximum of 2 chances can be earned by each Eligible Participant.

6. Three (3) draws (each a “**Draw**”) will be conducted on the following dates for Eligible Participants who qualify during the corresponding periods (each a “**Qualifying Period**”):

7. The winners will be picked from the pool of Eligible Participants during each Draw (each a “**Winner**”).
8. Eligible Participants who did not win in the first Draw conducted on 15 May 2025 (“**First Draw**”) shall remain eligible to participate in the second Draw on 16 Jun 2025 (“**Second Draw**”). Participants who did not win in the Second Draw shall remain eligible to participate in the third

Draw on 15 July 2025 ("**Third Draw**"), subject to the same eligibility requirements and conditions as set forth in these Terms.

9. Each Draw will be conducted in front of an independent scrutineer.

## Prizes

## Travel

## Collection

Such personal data may include without limitation your name, telephone number, email address, personal identification or passport number, as well as your image, picture, photographs or likeness. You confirm you have read and understood and that you agree to the StarHub Personal Data Protection Policy.
23. In addition to the foregoing, by participating in this Lucky Draw, you consent to us, our Strategic Partners and our Preferred Partners calling you or sending SMS to you via the Singapore telephone number(s) that you have submitted or that we may have in our records from time to time, for the abovementioned StarHub Additional Purposes and Preferred Partners Additional Purposes.

## **Others**
